The Monte Vista Chamber of Commerce and the Monte Vista Crane Festival Committee invite you to participate in the two-day Nature Arts and Craft Fair at the 39<sup>th</sup> Annual Monte Vista Crane Festival in Monte Vista, Colorado.

TIME: Friday, March 11<sup>th</sup> SET UP: 7:00 am-10 am

FAIR OPENS: 11 am-7:00 pm

Saturday, March 12<sup>th</sup> FAIR OPENS: 9:00 am

BREAK DOWN: 6:00 pm

FEE: **\$105.00 for a 10X10 booth on the aisle or outside, and \$120.00 for a corner.** Please note, corner booths are on a first come - first serve basis! **Please contact Chamber Manager before payment to see if there are corner booths available.** If you cancel after reserving a booth, you will receive a refund only if the space can be rented to another vendor.

**(Food Truck space will be the same cost as a 10X10 Booth.)**

**In addition, there is a \$40 refundable deposit. Vendors that set up on time and remain throughout the event will be refunded this deposit.**

All vendors are responsible for your own tables and chairs. Booths with electricity are limited and are available on a first come - first serve basis as well.

**DEADLINE: The deadline to register for a booth is March 4<sup>th</sup>, 2022.**

FOOD: There are outdoor spaces for food vendors, but you must be self-contained.

Each vendor must complete the release of liability and return it to the Monte Vista Chamber of Commerce.

**Each vendor is responsible for self-reporting their sales tax. The City of Monte Vista has a vendor fee of \$5 for all vendors. Please fill out their document return to the City of Monte Vista, NOT THE CHAMBER OF COMMERCE**

1. Agree that prior to participation I will inspect the facilities, equipment, and areas to be used, and if I believe any of them to be unsafe, I will immediately advise persons supervising the event, activity, facilities, or areas.
2. Acknowledge that I fully understand that my participation may involve risk or serious injury or death, including economic losses which may result not only from my own actions, inactions, or negligence, but also from the actions, inactions, or negligence of others, the condition of the facilities, equipment, or areas where the event or activity is being conducted, the rules of conduct, or this type of event or activity.
