## **What is the Taste of the San Luis Valley?**

The Taste of the San Luis Valley is a one day outdoor family event featuring many of our local restaurants presenting tasting portions of their signature food or beverage items. The purpose of the event is for people to enjoy the wide variety of dining and food products available in the San Luis Valley, and to give the restaurants an opportunity to introduce their establishments to more potential customers. In addition we would like to present many of the wonderful arts and crafts, and the diversity of food products of the Valley.

There will be music/Entertainment throughout the day.

Chefs will be invited to demonstrate their culinary arts, offering recipes and preparation guidance, making it easy to recreate at home.

Since this is held at Chapman Park – the layout is going to be free flowing and irregular, not necessarily laid out in a grid pattern.

## **Entry and Booth space fees:**

- 5' x 10' booth space \$35
- 10' x 10' booth space \$70
- If you need a 15' x 10' space you can make combinations.
- Vendors will be notified by email of their booth number by June 23, 2018.
- A map layout of the park with booth numbers will be included with this email.
- Booth space fees must be paid in advance of the event (no later than June 1) and include the attached registration form.
- Refundable Booth Deposit \$30. Vendors that set up on time and remain until at least 5:30 pm will be refunded this deposit. Late set up or early departure forfeits this deposit.
- Food products vendors offering small samples of their products (honey, cheese, herbs, etc.) are responsible for assuring proper food handling in accordance with Health Department regulations.
- 110 volt electrical service is available if necessary. Please indicate your electric supply needs on the registration form.

**Set up:**

- Starts at 6:30 am. The vendor booth spaces will be marked with the vendor booth number and corners marked with flagging stakes.
- Canopies are highly recommended within the assigned booth space.
- Wifi is available at the park – name and password will be provided with booth assignment. If there are any further instructions, the vendor check in and vendor assistance station is located North of the Glen Martinez Pavilion.

**Tear down:**

- ❖ Tear down is on Saturday, June 30, 2018 immediately after the close of the Festival.
- ❖ All vendors must clear their booths by 8:00 pm that night.

## Release and Waiver of Liability and Assumption of Risk Agreement

FOR GOOD AND VALUABLE CONSIDERATION, including permission to participate in the Taste of the San Luis Valley and related activities, I, for myself, my successor, heirs, assigns, executors, and administrators;

1. Agree that prior to participation I will inspect the facilities, equipment, and areas to be used, and if I believe any of them to be unsafe, I will immediately advise persons supervising the event, activity, facilities, or areas.
2. Acknowledge that I fully understand that my participation may involve risk or serious injury or death, including economic losses which may result not only from my own actions, inactions, or negligence, but also from the actions, inactions, or negligence of others, the condition of the facilities, equipment, or areas where the event or activity is being conducted, the rules of conduct, or this type of event or activity;
3. Assume any and all risks of personal injuries to myself, including medical or hospital bills, permanent or partial disability, death, and damage to my property, caused by or arising from my participation in the event or activity;
